the extension of the maturity date of Warrant No. 2 from June 30,
1992 to December 31, 1992; and

WHEREAS, pursuant to Section 50-901A, Idaho Code, the City is
authorized to publish, in lieu of the entire ordinance, a summary
thereof;


NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED as

from and after its passage and approval.


