A resolution of the Board of Directors of Bayview Water and Sewer District, Kootenai County, Idaho to establish a rate structure for all fees pertaining to installation, repairs and maintenance, commercial use, and reimbursable costs by the District relating thereto.

WHEREAS, Bayview Water and Sewer District, Kootenai County, Idaho (the "District") is a duly and properly formed water district under and by virtue of the constitution and laws of the State of Idaho and governed by an elected Board of Directors (the "Board");

WHEREAS, Idaho Code Section 42-3212(1) allows the District to fix and from time to time to increase or decrease water and sewer rates;

WHEREAS, the Board deems it advisable to adopt existing fees set by earlier ordinances and resolutions in one general fee resolution; and

WHEREAS, the Board has determined that the revised fees included in this Resolution are appropriate and are reasonably related to the purpose for which such fees are charged.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Bayview Water and Sewer District as follows:

- 1. That the fees set forth in Exhibit "A" attached hereto and made a part hereof, be in force and effect in all matters relating to fees from and after the 20th day of December, 2017. This rate schedule repeals and supersedes the previous rate schedule published with Resolution 2007-01.
- 2. That any Resolution or provision thereof which is inconsistent with this Resolution is hereby repealed.
- 3. That said rate and charges are, and shall continue to be, uniform as to all person or properties, which are of the same class.

This Resolution shall become and is effective as of the date of its adoption.
